









## 4<sup>th</sup> PRECINCT CLEAN/COURT/PROBATION INFORMATION

The following people are active or have been involved in criminal activity in the 4<sup>th</sup> Precinct and meet one or more of the following criteria (1) an active non-appearance bench warrant, (2) had a non-appearance bench warrant issued against them within the last 60 days, or (3) a stayed court disposition upon certain conditions, or (4) they have more than 20 arrest/suspect entries in the police report computer system (CAPRS) three of which are for livability offenses in the 4<sup>th</sup> Precinct area, or (5) they have more than 75 arrest/suspect entries in CAPRS.
